Membership Conditions

Membership Fee

The Annual Membership fee for Family Members is 10'000.00 USD.

- Membership valid for all family members of the same family business.
- Valid for twelve months (1 year)

 The membership invoice will be issued when we have received your registration. Upon payment you will be issued the THR membership number, which will give you and your family access to all Tharawat membership benefits.
